OFFICE ORDER

Subject: Amendment in Standard Request for Proposal (RFP) for Consultancy Services for preparation of DPR / Authority Engineer & National Highway Works on EPC mode under NHIDCL reg

As per standard RFP for Consultancy Services for preparation of DPR / Authority Engineer & National Highway Works on EPC mode issued by MoRT&H, the Bidder is required to furnish Bid Security/Performance Security in the form of a Bank Guarantees from the selected Scheduled Banks only with net worth specified in the relevant clause of RFP.

2. Further, based on time to time approval of competent authority in NHIDCL for acceptable list of Banks for the purpose of BG, relevant changes are made in the RFP floated by the Technical Divisions for Consultancy Services/EPC works. Many a time, the updated acceptable list of banks issued by Finance divisions is not updated in the RFP invited by the concerned Technical Divisions. Thus, in order to have the coherency in the action of all the concerned divisions, it is has been decided that instead of specifying the name of the Bank in the RFP, the name of the Banks shall be reflected on the NHIDCL's website, so that updated list of the Banks can be used by all the concerned Division as well as by the Bidder/Selected Bidder.

3. The relevant clause of the RFP for Consultancy Services for preparation of DPR / Authority Engineer & National Highway Works on EPC mode are modified to this effect as under:

RFP for DPR Consultancy:

Clause 6.1 of Letter of invitation & Clause 2.1 (a) Special Conditions of Contract

The consultant will furnish within 15 days of the issue of Letter of Acceptance (LOA), an unconditional Bank Guarantee equivalent to 10% of the total contract value from a Nationalized Bank, IDBI or ICICI/ ICICI Bank/ Foreign Bank/ EXIM Bank / Any Scheduled Commercial Bank approved by RBI having a net worth of not less than Rs.1000 crore as per latest Annual Report of the Bank amongst the list of banks available at NHIDCL website (<https://nhidcl.com/>) only . In the case of a Foreign Bank (issued by a Branch in India) the net worth
Performance Security shall be released within three months from date of foreclosure / termination.

RFP for Authority's Engineer

Clause 7.1 of Letter of invitation to Consultants

The successful consulting firm shall have to submit a Bank Guarantee (BG) for an amount of 10% of the Contract Value within 15 days of issue of LOA. The BG shall The BG shall be in the format specified in Appendix H of draft contract form and furnished from a Nationalised Bank, IDBI or ICICI/ICICI Bank/Foreign Bank/EXIM Bank / Any Scheduled Commercial Bank approved by RBI having a net worth of not less than 1000 crore as per latest Annual Report of the Bank amongst the list of banks available at NHIDCL website (<https://nhidcl.com/>) only. In the case of a Foreign Bank APS are same as those of Performance Security.

RFP for EPC works


Clause 2.20.1

The Bidder shall furnish as part of its BID, a BID Security referred to in Clause 1.2.4 herein above in the form of a bank guarantee issued by nationalised bank, or a Scheduled Bank in India having a net worth of at least Rs. 1,000 crore (Rs. one thousand crore), amongst the list of banks available at NHIDCL website (<https://nhidcl.com/>) only, in favour of the Authority in the format at Appendix-II (the "Bank Guarantee") and A scanned copy of the Bank Guarantee shall be uploaded on e-procurement portal while applying to the tender.

Clause 2.21.1

Within 30 (thirty) days of receipt of Letter of Acceptance, the selected Bidder shall furnish to the Authority an irrevocable and unconditional guarantee from a Bank, amongst the list of banks available at NHIDCL website (<https://nhidcl.com/>) only, in the form set forth in Appendix-VII (the "Performance Security") for an amount equal to 5% (five percent) of its Bid Price. In case of bids mentioned below, as part of the Performance Security.

4. All concerned are directed to ensure the compliance of this order.
