**DEBARMENT NOTICE**

**Subject:** Debarment of Sh. Antim Kumar Das from engagement in NHIDCL/MoRTH Projects for a period of 02 years.

It is hereby intimated to all the divisions/units of NHIDCL and other agencies of MoRTH that Sh. Antim Kumar Das was selected as the 'Team leader cum Senior Highway Engineer by M/s Hexa Co. in JV with M/s SOWIL Limited in association with M/s Casta Engineers Pvt. Ltd for the work of Consultancy services for Authority's Engineer for Supervision of the work of Improvement/ Up-gradation of existing 2-Lane Road to 4-Lane Divided Highway from (i) Taphukuki to Daili section (Pkg 4A) (Design Chainage from Km 262+175 to Km 274+610) (ii) Daili to Kuraopokpi section (Pkg-4B) (Design Chainage from Km 274+610 to Km 287+000) (iii) Kuraopokpi to Sekmai section (Pkg-5A) (Design Chainage from Km 287+000 to Km 297+700) (iv) Sekmai to Nilkhuthi section (Pkg 5B) (Design Chainage from Km 297 +700 to Km 308+460) of Imphal-Kohima road (NH-39) in the state of Manipur on EPC Mode.


2. RO-Imphal has informed that Sh. Antim Kumar Das has resigned from his post during the assignment period and is not available to render their services for the subject project.

3. Therefore, as per stipulation of the GCC Clause 4.5.6 of Contract Agreement, Sh. Antim Kumar Das is hereby debarred/blacklisted from participating in future projects of NHIDCL/MoRTH excluding agencies for a period of 02 years from the date of issue of this notice.
