- (i) M/s ABCI Infrastructure Pvt. Ltd.: The bidder needs to submit Appendix XII i.e. Certificate regarding Compliance with Restrictions under Rule 144 (xi) of the General Financial Rules.
- M/s BRN Infrastructures Pvt. Ltd. M/s SCONS Infrastructure Pvt. Ltd. :- The (ii) bidder has submitted their bid in JV and as per clause 2.2.2.4 of RFP, "The Joint Venture must collectively and individually satisfy the above qualification criteria i.e. JV shall cumulatively/collectively fulfill the 100% requirement." After assessing the threshold technical capacity of both the JV members, the individual JV members are meeting the minimum threshold technical capacity requirement as specified in clause 2.2.2.4 (i) of RFP but collectively the bidder is not meeting the 100% threshold technical capacity requirement as per clause 2.2.2.4 of RFP. The other member of JV has submitted total 03 projects for claiming their threshold technical capacity. Out of these, project code 'C' has been executed as a sub-contractor by the other member of JV, for which client certificate in support of approval of sub-contract in the name of the other member has not been submitted by the bidder. In this regard, as per Annexure-IV (footnote) stipulates that 'In case of unauthorized sub-contractor proof of authorize sub-contracting has to be submitted'. Accordingly, the project code 'C' has not been considered for assessing the threshold capacity. Hence, the bidder M/s BRN Infrastructures Pvt. Ltd. - M/s SCONS Infrastructure Pvt. Ltd. is technically nonresponsive as per clause 2.2.2.2 (i), 2.2.2.4 (i) & 3.1.6.1 of RFP.
- (iii) M/s Skylark Infra Engineering Pvt. Ltd.: The bidder is meeting the minimum required criteria for similar work as per clause 2.2.2.2 (ii) of RFP with code 'H'. The bidder has submitted completion certificate signed by the Authority's Engineer. Though the work has been completed, the bidder shall submit the experience certificate from the project owning department as per the instruction no. 16 under Annexure-IV of RFP. The bidder has been considered provisionally responsive and financial bid shall be opened subject to submission of certificate from the client indicating the value of work done for the requirement of similar work experience. Also, as per Annexure-I i.e. Details of Bidder submitted by the bidder in their technical bid states that the bid has been submitted in JV whereas, the POA and all other documents states that the bid has been submitted as a sole. Therefore, bidder needs to submit the clarification/amendment for the same.
- (iv) M/s Shivalaya Construction Co. Pvt. Ltd.: The bidder is meeting the minimum required criteria for similar work as per clause 2.2.2.2 (ii) of RFP. The bidder has submitted completion certificates signed by the Authority's Engineer. The TEC noted that though the works has been completed, the bidder shall submit the experience certificates from the project owning department as per the instruction no. 16 under Annexure-IV of RFP. The TEC deliberated the matter and decided that the bidder may be considered provisionally responsive and financial bid shall be opened subject to submission of certificate from the client indicating the value of work done for the requirement of similar work experience.
- (v) M/s Shri Balaji Construction Company: Financial bid of the bidder shall be opened subject to the submission of Original Bank Guarantee before opening of financial bids.
